PART I. GENERAL EXPECTATIONS

The **SOUTH PARK SCHOOL DISTRICT** agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with Section 1118 of the Elementary and Secondary Education Act (ESEA).
